Resident Andy Jackson questioned if this would be taxable. Attorney McKertich explained this law addresses the fees so this amendment does not. This would be taxable by the Town Assessor.

At 7:15 p.m. Councilman Whittaker asked if there was any discussion regarding the Verizon Cell Tower Resolution Approving a Cell Tower Special Use Permit for 350 Rabbit Path Road.

Nathan Vander Wall from Nixon & Peabody LLP (Verizon Representative) discussed all that had led up to this point and asked if anyone had any further questions he could answer.

In response to moving the tower it was the land owners view it would not be an option due to it affecting use of the campgrounds and golf course. Verizon representatives agreed this is still the best site for the tower.

Attorney McKertich aided the board members with completing part 2 and 3 of the SEQR Forms for environmental review, with all board responses indicating no moderate/large environmental impacts.

Motion for a negative declaration under SEQR with regard to the cell tower special use permit and to check Box A on the part 3 SEQR Form.
